ALL sporting equipment must remain in the Gymnasium. • Use care to prevent marring the gym floor. No outside shoes are to be worn on the gym floor. NO roller blades, roller skates, or skate boards are allowed. • Children under 13 MUST be accompanied by an adult. • There will be a replacement fee of \$25.00 in order to replace lost or stolen keyfob • Members are not granted access to the facility between 12:00 AM and 5:00 AM • Never permit a non-member to use your keyfob. • Do not allow someone to “tailgate” you into the gym. • Do not prop the entry door open. • You may be financially responsible for damage that occurs in the facility by permitting access to a non-member. 	<p>Hold Harmless Clause: The individual, organization, or group, including the individual signing on behalf of an organization, personally agrees to hold the City of St. Paul, Nebraska, and the St. Paul Development Corporation harmless from any claim or demand against the City of St. Paul, Nebraska, or St. Paul Development Corporation arising out of the use of the building by the organization or any claim or demand by any person on the premises by reason of the activity of or by invitation of such organization and the undersigned covenants to reimburse the City of St. Paul, Nebraska, or St. Paul Development Corporation for any legal expense incurred by the City of St. Paul, Nebraska, or St. Paul Development Corporation in defending such claim.</p> <p>The City of St. Paul, Nebraska and St. Paul Development Corporation shall not discriminate against any renter.
